No. 2012AP1652 Milwaukee Branch of the NAACP v. Scott Walker L.C.#2011CV5492

This court has today, by separate order, granted the petition for review filed in League of Women Voters of Wisconsin Education Network, Inc. v. Scott Walker, No. 2012AP584-AC, unpublished order (Nov. 20, 2013). An appeal involving related issues is currently pending in the court of appeals and has completed briefing. See Milwaukee Branch of the NAACP v. Scott Walker, No. 2012AP1652. In the interest of judicial economy, this court deems it appropriate to take jurisdiction of that appeal. Accordingly, upon the court's own motion, pursuant to Rule 809.61 and Wis. Const. Art. VII, § 3(3);

IT IS ORDERED that this court takes jurisdiction of Milwaukee Branch of the NAACP v. Scott Walker, No. 2012AP1652. The parties shall not file briefs unless directed by the court; and

IT IS FURTHER ORDERED that within 15 days of the date of this order each party shall provide the clerk of this court with 17 copies of the briefs filed by that party in the court of appeals; and

IT IS FURTHER ORDERED that this case be scheduled for oral argument on the same calendar assignment as No. 2012AP584-AC, League of Women Voters of Wisconsin Education Network, Inc. v. Scott Walker.
