## PETITION FOR REVIEW

Pursuant to Clean Air Act Section 307(b)(1), 42 U.S.C. § 7607(b)(1), the Administrative Procedure Act, 5 U.S.C. §§ 553(e) & 702, and Federal Rule of Appellate Procedure 15(a), the State of Wisconsin hereby petitions this Court for review of the final rule of the U.S. Environmental Protection Agency, titled "Findings of Failure to Attain and Reclassification of Areas in Illinois, Indiana, Michigan, Ohio, and Wisconsin as Serious for the 2015 Ozone National Ambient Air Quality Standards," published in the Federal Register at

89 Fed. Reg. 101,901 (December 17, 2024) (EPA Docket No. EPA-R05-OAR-2024-0546). A copy of the rule is attached to this petition.

This Court has jurisdiction and is the proper venue for this action, under 42 U.S.C. § 7607(b)(1), because the final rule is "locally or regionally applicable" and thus is reviewable "only in the United States Court of Appeals for the appropriate circuit." *Id.* In the final rule, EPA determined that three Moderate nonattainment areas in Wisconsin failed to attain the 2015 ozone National Ambient Air Quality Standards (NAAQS) by the attainment date of August 3, 2024, and therefore reclassified those areas to Serious nonattainment for the 2015 ozone NAAQS. EPA also did not make any findings that the final rule is "based on a determination of nationwide scope or effect." *Id.* 

This petition for review is timely under 42 U.S.C. § 7607(b)(1), Fed. R. App. Pro. 26(a)(1)(C), and the final rule, which states that "petitions for judicial review of this action must be filed in the United States Court of Appeals for the appropriate circuit by February 18, 2025." 89 Fed. Reg. 101, 907.
